RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS ORDERING A SPECIAL ELECTION ON PROPOSED AMENDMENTS TO THE HOME CHARTER

WHEREAS, the Home Rule Charter for the City of Pflugerville, Texas, allows charter amendments in accordance with the laws of the State of Texas; and

WHEREAS, in accordance with Texas Local Government Code, Chapter 9, the City Council finds it appropriate to submit proposed charter amendments on its own motion to the qualified voters of the City of Pflugerville for their consideration.

WHEREAS, the City of Pflugerville enters into agreements with Travis County and Williamson County respectively to conduct the City's elections, pursuant to *Chapter 31*, *Tex. Elec. Code, and Chapter 791*, *Tex. Gov't Code* and such agreements provide for political subdivisions that hold elections on the same day in all or part of the same territory to hold joint elections as authorized in *Chapter 271*, *Tex. Elec. Code*; and

WHEREAS, the Travis County Clerk is designated as the Travis County Election Officer and the City of Pflugerville has appointed the Travis County Election Officer to serve as the City of Pflugerville's Election Officer and Early Voting Clerk to conduct the City's elections through its election agreement with Travis County; and

WHEREAS, the Williamson County Elections Administrator is designated as the Williamson County Election Officer and the City of Pflugerville has appointed the Williamson County Election Officer to serve as the City of Pflugerville's Election Officer and Early Voting Clerk to conduct the City's elections through its election agreement with Williamson County; NOW THEREFORE,

NOW THEREFORE,

BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS, THAT:

- 1. The matters and facts set out in the preamble of this order are hereby found and declared to be true and complete.
- 2. A special election shall be held for the City of Pflugerville, Texas (the "City") on the 7th day of November 2023, between the hours of 7:00 a.m. and 7:00 p.m. to consider amendments to the City of Pflugerville's Home Rule Charter.

- 3. Notice of the election shall be given and the election shall be held in compliance with the provisions of the Texas Election Code in all respects. The ballots for the election shall comply with the Texas Election Code and be in the form provided by the City to the Travis County and Williamson County Election Officers for use on the voting devices and ballots used by the Travis County and the Williamson County Election Officers.
- 4. The Travis County Election Officer and his/her employees and appointees, the Williamson County Election Officer and his/her employees and appointees, and the election judges, alternate judges and clerks properly appointed for the election shall hold and conduct the election in the manner provided by agreement with the City and the law governing the holding of general elections by home rule cities of the State of Texas; and the official ballots, together with such other election materials as are required by the Texas Election Code, shall be prepared in both the English and Spanish languages and shall contain such provisions, markings and language as is required by law.
- 5. The election precincts for the election shall be the election precincts established by Travis County and Williamson County respectively, provided that each shall contain and include geographic area that is within the City. Polling places for the election shall be at the locations established by the City in consultation with Travis County and Williamson County. The polls shall remain open on the day of the election from 7:00 a.m. to 7:00 p.m. The returns for precincts in Travis County will be provided by precinct and the Travis County Election Officer shall tabulate and provide the election returns for the election. The returns for precincts in Williamson County will be provided by precinct and the Williamson County Election Officer shall tabulate and provide the election returns for the
- 6. The presiding judges, alternate presiding judges and clerks for the election shall be selected and appointed by Travis County and Williamson County and their appointees in compliance with the requirements of state law, and such judges and clerks so selected by Travis County and Williamson County and their appointees are hereby designated and appointed by the City Council as the election officers, judges and clerks, respectively, for the holding of said general election. The presiding judges, alternate presiding judges and clerks shall perform the functions and duties of their respective positions that are provided by state law.
- 7. Early voting, both by personal appearance and by mail, will be conducted by the Travis County Election Officer, and the Williamson County Election Officer who are designated and appointed as Early Voting Clerk for voters in their respective counties, in accordance with the Texas Election Code. Early voting by personal appearance shall be conducted at places and locations authorized by state law, the City, and the Travis and Williamson County Election Officers. Early voting shall commence on October 23, 2023 and continue through November 3, 2023. A list of Election Day and early voting locations are attached as Exhibits A and B and are subject to change.
- 8. Voting Locations, Applications and Ballots.

Williamson County Early Voting Clerk P. O. Box 209, Georgetown, TX 78627

Applications for voting by mail for all residents of the City shall be received, not postmarked, by October 27, 2023.

- 9. All qualified resident electors of the City shall be entitled to vote in the election.
- 10. At the election, the Measures listed on Exhibit "C" shall be submitted to the voters in in the form of the Propositions listed on Exhibit "D".
- 11. The City Secretary is authorized to give or cause to be given notices required for the election, and to take such other and further action as is required to conduct the election in compliance with the Texas Local Government Code, Texas Election Code and City Charter; provided that, pursuant to the Election Agreements between Travis County and the City, and Williamson County and the City; the County Election Officers shall have the duty and be responsible for organizing and conducting the election in compliance with the Texas Election Code; and for providing all services specified to be provided in the Election Agreements. The County Election Officers shall give the notices required by the Tex. Elec. Code to be given for the election not required to be given by the City under the Election

Measure A:

ARTICLE III. THE CITY COUNCIL

Section 3.04. Compensation

Members of the city council shall serve with compensation. Each Council Member shall be compensated nine thousand dollars (\$9,000.00) annually and the Mayor shall be compensated twelve thousand dollars (\$12,000) annually. In addition, each Councilmember shall be entitled to reimbursement for their actual and necessary expenses incurred in the performance of their specific official duties of office, upon approval by City Council. without compensation, but and shall be entitled to payment of or reimbursement for all necessary expenses incurred in the performance of official duties, upon approval by the city council.

Measure B:

ARTICLE IV. ADMINISTRATIVE SERVICES

Section 4.07. Executive Assistant to City Council

The city council shall appoint an executive assistant to the City Council, who shall assist the city council in the performance of their duties as city council members and the legislative body of the City. The city council executive assistant shall serve at the will of the council and shall receive compensation as fixed by the council. The executive assistant shall assist the city council and its individual members by acting as a point of contact, assisting with information and document flow, managing calendars and meetings, and managing other business and responsibilities as directed by the city council.
