ORDINANCE NO. 230905-B

AN ORDINANCE OF THE CITY OF SUNSET VALLEY, TEXAS, DECLARING THE ELECTION OF UNOPPOSED CANDIDATES KAREN MEDICUS, DAVID BOURELL, AND RUDI ROSENGARTEN AS CITY COUNCIL MEMBERS, PROVIDING FOR COMPLIANCE WITH THE TEXAS ELECTION CODE REGARDING NOTICE OF SUCH DECLARATION; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the City Council ordered an election to be held on November 7, 2023 to fill the vacancies in expiring offices for three (3) City Council seats.

WHEREAS, both the deadline for candidates to file an application to appear on the ballot and the deadline to file a declaration to appear as a write-in candidate in such election have passed;

WHEREAS, no one has filed a declaration to appear as a write-in candidate, and only Karen Medicus, David Bourell, and Rudi Rosengarten have filed applications to appear on the ballot to fill the three (3) vacancies on City Council;

WHEREAS, the City Secretary has delivered a certification to the City Council pursuant to Texas Election Code Section 2.052 certifying that Karen Medicus, David Bourell, and Rudi Rosengarten are unopposed in filling the three (3) vacancies on City Council;

WHEREAS, Texas Election Code Section 2.053 provides that the City Council may declare each unopposed candidate elected to the office.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SUNSET VALLEY, TEXAS, THAT:

- **SECTION 1.** All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council, and are hereby approved and incorporated into the body of this Ordinance as if copied in their entirety.
- **SECTION 2.** Karen Medicus, David Bourell, and Rudi Rosengarten are hereby elected to the City Council, to assume such office in the time and manner as though elected at the election on November 7, 2023. The election to fill the three (3) vacancies for City Council seats previously ordered for November 7, 2023 shall not be held.
- **SECTION 3.** In conformance with Texas Election Code Section 2.053, a copy of this ordinance will be posted on Election Day at the polling place that is used in the election.
- **SECTION 4.** Severability. Should any part, sentence or phrase of this Ordinance be determined to be unlawful, void or unenforceable, the validity of the remaining portions of this Ordinance shall not be adversely affected. No portion of this Ordinance shall fail or become inoperative by reason of the invalidity of any other part. All provisions of this Ordinance are hereby declared to be severable.
- **SECTION 5.** Effective Date. This Ordinance is effective immediately upon its passage and approval.
